IV. CITIZEN'S INPUT:

David Sandoz 208 Frontier - City needs a sidewalk on Sergeant Square Drive all the way north. A lot of runners and walkers are using the street.

Judi Belt 219 Frontier - Concern for the garbage and trash along the south fence of the former Convergys site.

Mayor Pro-Tem Hanson stated that, due to notification requirements, the Public Hearing for Rezoning 102 Sergeant Square Drive will be rescheduled for September 10th. The public was allowed to express comments if desired.

Richard Kober 203 Frontier - Concerned about what business(es) will go in the old Convergys building and parking lot. Concerned about traffic - apartment traffic is causing issues already, what type of traffic, and when trucks operate.

Kathy Sandoz 208 Frontier - Concerns with the traffic noise and the possible business operations. Concerned that rezoning of Light Industrial/Manufacturing now could allow

other business in the future to move in that is not compatible and may not require public input. Discussed how there is a primary school right across the street and the possible negative impact of this rezoning.

Thomas Beuzekom 218 Frontier - Believes some families want to move away if this zoning and business is allowed. Concerned about the great neighborhood breaking up.

Elmer Smith 205 Frontier - Concerned with what the property valuation would do with a rezoning.

David Sandoz 208 Frontier - Asked why we should rezone this area when we have the Dogwood area site ready for this type of occupancy. Concerned for the screening of the residential neighborhood. Asked about how many trucks would there be and how would the city control that amount? What is the remedy for a business failing to meet the conditions of the site?

Diane Lenz 215 Frontier - Mentioned that a local realtor said her home value will go down with this rezoning. Asked if the City had options to help offset their property value decreases.

Richard Kober 203 Frontier - Asked for clarification on what the board of adjustment does. He asked if there was still going to be a meeting with them Aug 28th.

John Hauswald 213 Frontier - Moved here in 1996 and was awakened each year with the clearing of the parking lot of snow behind him. Expressed concerns for trucks that get lost going to the facility and what will they do to get turned around.

X. ADMINISTRATOR'S REPORT:

Aaron Lincoln sat down with staff to list out and highlight the projects that need attention and will be working to move these along. Was contacted by the DNR about a forgivable loan plan that will be coming out at the beginning of next year, which my help in reducing the burden of costs for the Water Plant rehabilitation project. Discussed timing of closing splash pad as we have never done it before and we need to seal the pavement joints and winterize the facility. Potential date is September 15-18 to close. Ongoing discussions and language review for the wastewater treatment agreement with Sioux City.

Jim Linafelter wanted to congratulate Cathy Bishop for her nice write-up in the Siouxland Woman Magazine. Also wished luck to all fall sports and continued academic success. Ron Hanson wanted to thank City staff and volunteers for an enjoyable Pioneer Valley Days and was

even more proud of how the community cleaned up when the activities were complete. Ron would like to consider removing on street parking across from the credit union on Sergeant Square Drive due to traffic safety. He commented on how proud he is of the police department for being safe and doing a great job. He also met the Oak Hills neighborhood watch committee and likes what he sees with growing numbers. Nicole Cleveland met with the neighborhood watch committee as well and said numbers were up to 10 participants. She reminded everyone that school has started and to be careful driving. Also there will be a boy scout tavern dinner on Friday night Aug 30th before the home football game. Carol Clark attended the recent planning and zoning meeting and plans to attend the board of adjustments as each group considers the rezoning and conditional use for 102 Sergeant Square Drive. Carol mentioned that the library has started a book club and would love to see people join. She also congratulated Cathy Bishop and mentioned that she would love to see how proud people are of our school district by showing support for things going on. Bill Gaukel echoed most of the comments; asked people to get informed about the school bond issue and then vote. He also mentioned the extra traffic around the football games to watch out for children during this time.
